It ensures stakeholders, including organizers, participants, observers, and voters, understand the rights, obligations, and procedures, leading to increased legal compliance and a fair process. Effective socialisation can also reduce conflicts and disputes, fostering public trust in the election supervisor's integrity. Activities were conducted to increase understanding of Bawaslu regulations and non-regulations during the 2024 General Election. In collaboration with Bawaslu Baubau City, participants included Sub-District Supervisory Committees and Election Monitors. Understanding rules promotes equality, fairness, and social stability by preventing abuse and utilizing legal loopholes. It also allows for organized and productive interactions, preventing conflicts and chaos. Prioritizing rules is crucial for individuals and organizations to make informed decisions, maintain equality, and preserve social stability. General elections are one of the tools in a democratic system to determine the administration of the state in accordance with the will of the people. (Syahputra & Rajief, 2022). Elections are an important element of democracy. The centrality of electoral positions is their ability to distinguish between democratic and non-democratic political systems (Ririhena, 2024). In line with the objectives of implementing elections, the implementation of elections must be able to maintain the quality of elections with integrity and accountability. However, in reality, violations and fraud still often occur in every election with various forms and at every stage (Riani et al., 2023). Elections in Indonesia are held to elect members of the DPR, DPD, Provincial DPRD, Regency / City DPRD throughout Indonesia or often referred to as legislative elections. Elections are also held to elect the President and Vice President, Governors, Regents/Mayors (Sianipar & Sijabat, 2024).

Law enforcement can be said to have been enforced if the objectives of the legal policy, namely Law Number 7 of 2017 concerning General Elections, have achieved their objectives, the objectives of elections in general are, the constitutional transfer of power to implement the sovereignty of the people in accordance with the mandate of the constitution, fulfilling the basic rights of the people (Nasution, 2023), in order to implement the election objectives for better quality, it is necessary for various elements of society to participate in monitoring the 2024 elections massively (Andrizal et al.,

2023; Hidayat et al., 2023). The Bengkalis Regency Election Supervisory Agency strives to ensure that the simultaneous elections run according to applicable regulations and can minimise the occurrence of violations and disputes in the 2024 elections and regional elections (Mukhlasin & Lestari, 2023). The conduct of elections, from the initial process to the final results, has been regulated by law to ensure the success of the process. The successful conduct of elections is highly dependent on adherence to the applicable rules and regulations. (Seran & Apriliyani, 2024).

The General Election Commission (KPU) and the Election Supervisory Agency (Bawaslu) have worked optimally but need to be strengthened by stake holders, one of which is synergising with academics as well as efforts to increase participation. (Abqa et al., 2022), efforts to improve the legal knowledge of organisers at the sub-district level so that they can participate optimally in the ongoing political system, in accordance with the understanding of popular sovereignty or democracy that elections must be truly beneficial to the state (Sa'ban et al., 2019). One of Bawaslu's duties is preventive action. forms of prevention can be carried out in patrols, appeals or socialisation activities such as the activities we are currently attending. Ahead of the voting and counting of votes, it is very necessary to provide comprehensive knowledge for the elected Panwascam. This is due to the vital and heavy duties of Panwascam on election day.

3. Metode

Community service activities (PKM) are carried out in the form of socialisation aimed at increasing understanding for the Election Sub-District Supervisory Committee (Panwascam) of the implementation of Bawaslu regulations and non-regulations during the 2024 General Election activity process. Implementation of Bawaslu regulations and non-regulations during the 2024 General Election activity process. This PKM activity was carried out in collaboration with Bawaslu Baubau City with the preparation stage in the form of preparing an activity plan for the meeting to implement the socialisation activities. In this activity, participants consisted of Sub-District Supervisory Committees in Baubau City and Election Monitors, then the implementation of activities in the form of socialisation in the form of providing material on Bawaslu's regulations and non-regulations. In this service programme, the team provided material on Non Bawaslu Rules and Regulations delivered by Eko Satria, S.H., M.H. academics from the Faculty of Law, University of Muhammadiyah Buton who are also active researchers at the Cendekia Reseacrh Center (CRC) Baubau Institute (Figure 1). In this material, it is explained that Panwascam must be able to comprehensively understand every regulation and non-Bawaslu regulation that must be applied at any time in accordance with its designation, that the authority possessed by Panwascam is a strategic authority in terms of supervision at the sub-district level in the election process in Baubau City. In his presentation, he outlined several substantial matters of interest in the electoral process.

Regulations and Legal Products, Bawaslu is certainly more effective in regulating the procedures for how Bawaslu works in conducting supervision and law enforcement in elections, using a digitalization system will facilitate the implementation of Perbawaslu because Bawaslu is a Hierarchical Institution, therefore any regulations issued by Bawaslu RI must be applied to the lower levels. but the absolute duty of all of us is to protect the right to vote.
